**NOTICE FOR EMPANELMENT OF SPECIAL PUBLIC PROSECUTORS (SPPs)**

**Date: 01/03/2019**

Applications are invited from advocates of substantial standing and repute with good academic credentials for the empanelment of Special Public Prosecutor for representing prosecution cases of the Income Tax Department in the Sessions Court and Addl. Chief Metropolitan Magistrate Courts or the appropriate Court of Mumbai in terms of CBDT Instruction No. 06 of 2016 dated 07.09.2016 in F. No. 279/Misc./M-77/2011-IT-J.

2. The number of SPPs required to be empaneled is 12. The empanelment will be for 18 months. Suitable and experienced advocates, having knowledge of Income Tax and Other matters including criminal matters and have been in practice for not less than 7 years are eligible and may apply for the same. The payment of fees will be governed by the Instructions issued by Central Board of Direct Taxes, Government of India, from time to time.

3. The advocates desirous and eligible for the post, in terms of the above said Instruction may send completed applications to the following address.

5. The advocates who are existing on the panel of Ministry of Law and Justice will have to apply separately for appointment as Special Public Prosecutor in the panel of the Income Tax Department.

6. All aspiring applicants may take note that canvassing in any form shall constitute a disqualification.

7. The last date for receipt of application is **25/03/2019** Applications found to be deficient in any respect shall also be summarily rejected.
