TELEPHONE NETWORK CABLING, TELEPHONE INSTRUMENTS (1000-1200 NOS.)

Sealed quotations are invited from bidders qualifying the eligibility criteria and other terms and conditions mentioned hereunder for undertaking the **Annual Maintenance Contract (AMC)** of (1) Telephone Network cabling, Telephone Instruments (1000-1200 nos.) and Plan [1+1](40-50 nos.) and (2) Telepax make EPAC system quipped with 72 extensions (Hotlines) installed at Aayakar Bhavan building in Mumbai for one year starting from the date of award of contract which is however extendable further at the discretion of the Department.

A. Specification of Services required:

- (i) Non-comprehensive Annual Maintenance Contract for -
 - (a) Telephone Network cabling (EPABX field cabling network upto MDF Junction and other cabling related to telephones), Telephone Instruments and Plan [1+1] and
 - (b) Telephone Network cabling (EPAC field cabling network for hotlines) and maintenance of Telepax make EPAC system quipped with 72 extensions (Hotlines)
- (ii) Preventive Maintenance visits, weekly by Engineer within normal working hours to up-keep the telephone network.
- (iii) Provision of a Technician on all working days to attend any number of break down calls any day during the validity period of the agreement.
- (iv) Deputation of Engineer as and when required

B. Eligibility Criteria:

- (i) The Bidder must have minimum experience of 3 years in the Service/maintenance of telephone networking & cabling and handling of EPABX and EPAC.
- (ii) The bidder must have a minimum annual turnover of Rs. 20 lacs from the service/maintenance of Telephone Network Cabling and Instruments in any of the last 3 financial year's i.e. 2018-19, 2019-20 and 2020-21.
- (iii) Necessary documentary proof and details should be submitted with the quotation documents in respect of item numbers (i), and (ii) mentioned above.

C. Payment terms:

- (i) The AMC Charges are payable on half yearly basis i.e. 50% of the contractual amount will be paid after 6 months of the initiation of contract period and balance 50% after satisfactory completion of the contract period on submission of bills duly certified by the competent authority.
- (ii) No payment shall be made for the part of work.
- (iii) No payment shall be made if the contract is terminated because of unsatisfactory work.

D. Other Terms and Conditions of the Contract:

- (i) Bids ones submitted shall not be allowed to be withdrawn and any default after acceptance of the bid shall be deemed to be non compliance of terms of contract.
- (ii) The technical bid must accompany with copies of three Return of Income filed for A. Yrs 2018-19, 2019-20 and 2020-21 with proof of turnover in these years (Return of Income and Balance Sheet).
- (iii) The Financial Bid will be opened only if the bidder fulfills the eligibility criteria and conditions stipulated in the "Technical Bid"

- (iv) The Income Tax Department reserves the right to accept or reject any bid without assigning any reason.
- (v) Two separate bids viz. Technical Bid and Financial Bid are to be submitted by each bidder.
- (vi) Tender bid should be submitted in a big sealed envelope marked as "Tender- AMC for Telephone Network cabling and Instruments" containing two smaller sealed envelopes marked as "Technical Bid' & "Financial Bid'
- (vii) This office reserves the right to terminate the contract at any stage even during the initial period also after giving a week's notice to the firm.
- (viii) For each default of service Rs.500/- will be charged as penalty.
- (ix) Rates quoted should be all inclusive.
- (x) The vendor will not have any legal right to proceed against the Department in the event of late payment due to unforeseen reasons.
- (xi) No demand for revision of rate on any account shall be entertained during the contract period.
- (xii) The quotation documents are to be submitted in the office of the ITO (HQ)Admn.-III, Mumbai at Room No.345, Third floor, Aaykar Bhavan, M. K. Road, Mumbai 400 020 on or before 1.30 p.m on 07.03.2022 on Bid will not be accepted thereafter.
